1. Apologies

1.1 Apologies were received from Charles Greenlees.

2. Minutes of Committee Meeting 28th July 2025

2.1 The minutes of the Committee meeting were accepted.

4. Treasurer's Report

4.1 Allan presented the Financial Summary up to 30th September. Total Income was £17,883. Total Expenditure was £15,914 with depreciation of £1,283. There is a surplus of £686 to 30th September. Miscellaneous expenses include solicitors' costs relating to the CIO and Director training courses. Business rates are payable by the CIO with 80% relief.

4.2 Allan presented the updated Budget sheet for 2025.

5. Membership Secretary's Report

5.1 Allan advised that there were now 111 members. The learners from the October 2024 course should all now be members of the club. Steve will check the position with Jeremy.

5.2 Hosting on Monday and Thursday afternoons – we will keep the current system for the time being and then move to no hosting from January 2026. There will be an explanation on how to use Pianola partner finder. Allan will send out an email accordingly.

6. Charitable Incorporated Organisation (CIO) progress report

6.1 There is no further progress to report.
